

# Terms and Conditions of Participation

## Hahn Air "Heart-a-Stack" Competition

#### **Preface**

Hahn Air Lines GmbH is organising the "Hahn Air Heart-a-Stack Competition" from February 11th, 2020 until February 21st, 2020, in which participating travel agencies (You!) can win prizes according to these Terms and Conditions of Participation.

### I. Organiser

The "Hahn Air Heart-a-Stack Competition" is being organised by Hahn Air Lines GmbH, An der Trift 65, 63303 Dreieich, Germany (hereinafter: "Hahn Air"). Hahn Air is the recipient of all information and messages that will be provided. Any questions, comments or complaints should be directed to Hahn Air through fun@hahnair.com.

# **II. Participation**

The "Hahn Air Heart-a-Stack Competition" and your participation in it are subject to the present Terms and Conditions of Participation. By participating in the "Hahn Air Heart-a-Stack Competition", you acknowledge and accept the Terms and Conditions of Participation and that these are binding.

Participation in the "Hahn Air Heart-a-Stack Competition" is open to travel agencies who have accepted the Terms and Conditions of Participation. Only employees of travel agencies who are of legal age may participate in the drawing.

In order to participate in the drawing, you need to complete our "Hahn Air Heart-a-Stack Competition" that is available in the logged-in area of www.hahnair.com. During the 60-second game time, you will throw arrows at characters holding hearts, earning points for every heart you hit. If you knock down the black heart you will lose points. Upon completion of the game, you will be able to enter your personal details in a pop-up window. Please remember to enter all of the requested information, so we can correctly identify you in case of victory.

This "Hahn Air Heart-a-Stack Competition" is only aimed at countries under which legislation this raffle is legal. You declare that your participation in the "Hahn Air Heart-a-Stack Competition" does not violate the laws of your country. If your travel agency is based in a country under whose legal system the "Hahn Air Heart-a-Stack Competition" is illegal, you may not participate in the drawing. However, you are welcome to test your skills in our "Hahn Air Heart-a-Stack Competition".

Employees of Saspo Holding GmbH or its affiliated companies, its cooperating partners and sponsors or people involved in implementing the "Hahn Air Heart-a-Stack Competition" are prohibited from participating in the "Hahn Air Heart-a-Stack Competition".

Travel agents who attempt to manipulate or interfere with the competition in any way, or who do not comply with the Terms and Conditions of Participation will immediately be excluded from participating in the "Hahn Air Heart-a-Stack Competition".



# III. Duration suspension and termination, changes to the Terms and Conditions of Participation

The period of the "Hahn Air Heart-a-Stack Competition" is from February 11th, 2020 10:00h (CET) until February 21st, 2020, 09:00h (CET). After the end of this period, you can no longer participate in the "Hahn Air Heart-a-Stack Competition".

Hahn Air reserves the right to change or to amend the Terms and Conditions of Participation at any time without prior notice. If any rule or regulation of the Terms and Conditions of Participation should be or become invalid, the validity of the remaining terms and conditions shall remain unaffected.

Hahn Air reserves the right to end or to suspend the "Hahn Air Heart-a-Stack Competition" at any time without prior notice. This applies in particular, but not limited to, any circumstances that are disrupting or preventing the proper implementation or scheduled end of the "Hahn Air Heart-a-Stack Competition".

# IV. Winners, prizes, no entitlement to win, announcing the winners

There is only one winner in the "Hahn Air Heart-a-Stack Competition". Each participant can only be a winner once. Only the person entering the competition shall be considered a participant - this is the travel agent whose data is entered on the entry form. There is no entitlement to win. Prizes cannot be transferred to third parties.

The winner of the "Hahn Air Heart-a-Stack Competition" will be determined by the highest score reached on February 21st, 2020, at 09:00h (CET) at the main office of Hahn Air Lines GmbH, An der Trift 65, 63303 Dreieich, Germany.

If you win, you will be asked to give your consent to publish your name, travel agency and place of residency in Hahn Air's newsletter, on the internet and social media pages (www.hahnair.com, Facebook, Twitter, etc).

The prize will be a "Flight Voucher". The "Flight Voucher is limited in value to a maximum of EUR 1000 ("one thousand Euros").

The "Flight Voucher" is valid for the fare price excluding taxes for one flight ticket issued on HR ticketing stock. It is valid for one year starting from the date of issuance stated on the voucher. After this year, the Flight Voucher will be invalid. Flight Vouchers are not transferable. In the event of a cancellation, no monies will be paid out. In the event of a re-booking, any re-booking fees must be paid by the winner. The Flight Voucher shall not be used in order to pay for any such fees — even if the Flight Voucher exceeds the fare price. Should the fare price exceed the value of the Flight Voucher, the winner will have to pay the difference between the fare price and the Flight Voucher. If the value of the Flight Voucher exceeds the fare price, no monies will be paid out.

The winner will be notified about further details regarding the prize after the draw.

Hahn Air reserves the right to modify or replace all prizes at any time at its own discretion until the validity expires and without further notice insofar as the new prizes are of equivalent or higher value. The prizemay also be replaced or honoured after the expiry of the validity at Hahn Air's own discretion.

# V. Data protection



Within the context of the "Hahn Air Heart-a-Stack Competition", the disclosure of personal data is voluntary. You are aware, however, that participation requires the disclosure of certain personal information. Information given within the context of the "Hahn Air Heart-a-Stack Competition" will be treated confidentially and in accordance with statutory data protection provisions. The data will be collected by Hahn Air Lines GmbH in connection with the "Hahn Air Heart-a-Stack Competition" and processed and used only for this purpose. The data collected in the context of the "Hahn Air Heart-a-Stack Competition" will serve exclusively for identifying and notifying the participants and will not be exploited for any further purpose.

Data will not be transmitted to third parties, provided this is not necessary for the implementation and execution of the "Hahn Air Heart-a-Stack Competition". You are aware of and consent that in order to implement the "Hahn Air Heart-a-Stack Competition", and in particular in order to announce the winner of the prize, a data exchange might be carried out between Hahn Air Lines GmbH, its sister companies and its parent company Saspo Holding GmbH. You hereby authorise Hahn Air Lines GmbH and its aforementioned affiliates to exchange such data and to use and process the data for the purposes of the "Hahn Air Heart-a-Stack Competition".

These liability provisions/regulations equally apply to the affiliates mentioned under section V.

Hahn Air Lines GmbH and their affiliated companies shall be released from all obligations once the prizes have been handed over.
