

Terms and Conditions of Participation

Hahn Air “Match the Pairs” Game

Preface

Hahn Air Lines GmbH is organising the “Hahn Air Match the Pairs Game” from December 5th, 2018 until December 19th, 2018. Travel agencies can participate in the game; however, no prizes will be awarded to the top scorers.

I. Organiser

The “Hahn Air Match the Pairs Game” is being organised by Hahn Air Lines GmbH, An der Trift 65, D-63303 Dreieich, Germany (hereinafter: “Hahn Air”). Hahn Air is the recipient of all information and messages that will be provided. Any questions, comments or complaints should be directed to Hahn Air through fun@hahnair.com.

II. Participation

The “Hahn Air Match the Pairs Game” and your participation in it are subject to the present Terms and Conditions of Participation. By participating in the “Hahn Air Match the Pairs Game”, you acknowledge and accept the Terms and Conditions of Participation and that these are binding.

Participation in the “Hahn Air Match the Pairs Game” is open to travel agencies who have accepted the Terms and Conditions of Participation.

During the game, you will be shown some cards with their faces down. Try to find matches by turning over two cards at a time. When the two cards match, they will be removed. If they are different, they are turned face down again. The game is over when you have matched all of the pairs and all the cards are gone. Upon completion of the game, you will be able to enter your name that will be listed in a high score.

Travel agents who attempt to manipulate or interfere with the game in any way, or who do not comply with the Terms and Conditions of Participation will immediately be excluded from participating in the “Hahn Air Match the Pairs Game”.

III. Duration suspension and termination, changes to the Terms and Conditions of Participation

The period of the “Hahn Air Match the Pairs Game” is from December 5th, 2018 until December 19th, 2018, 10:00h (CET). After the end of this period, you can no longer participate in the “Hahn Air Match the Pairs Game”.

Hahn Air reserves the right to change or to amend the Terms and Conditions of Participation at any time without prior notice. If any rule or regulation of the Terms and Conditions of Participation should be or become invalid, the validity of the remaining terms and conditions shall remain unaffected.

Hahn Air reserves the right to end or to suspend the “Hahn Air Match the Pairs Game” at any time without prior notice. This applies in particular, but not limited to, any circumstances that are disrupting or preventing the proper implementation or scheduled end of the “Hahn Air Match the Pairs Game”.

IV. Winners and prizes

There are neither winners nor prizes in the “Hahn Air Match the Pairs Game”. It is purely for entertainment purposes.

V. Data protection

Within the context of the “Hahn Air Match the Pairs Game”, the disclosure of personal data is voluntary. You are aware, however, that participation requires the disclosure of certain personal information. Information given within the context of the “Hahn Air Match the Pairs Game” will be treated confidentially and in accordance with statutory data protection provisions. The data will be collected by Hahn Air Lines GmbH in connection with the “Hahn Air Match the Pairs Game” and processed and used only for this purpose. The data collected in the context of the “Hahn Air Match the Pairs Game” will serve exclusively for identifying and notifying the participants and will not be exploited for any further purpose.

Data will not be transmitted to third parties, provided this is not necessary for the implementation and execution of the “Hahn Air Match the Pairs Game”. You are aware of and consent that in order to implement the “Hahn Air Match the Pairs Game” a data exchange might be carried out between Hahn Air Lines GmbH, its sister companies and its parent company Saspo Holding GmbH. You hereby authorise Hahn Air Lines GmbH and its aforementioned affiliates to exchange such data and to use and process the data for the purposes of the “Hahn Air Match the Pairs Game”.

The data collected by the organiser within the framework of the “Hahn Air Match the Pairs Game” will only be stored until the purpose for which they were collected has been fulfilled. Where retention periods stipulated by commercial and tax laws are to be observed, certain data may be stored for up to 10 years.

In the context of the “Hahn Air Match the Pairs Game” the participants have declared to be in agreement with the collection, process and use of their personal data in the framework of the “Hahn Air Match the Pairs Game”.

You may revoke your consent at any time by sending an email to fun@hahnair.com. With the revocation, however, your participation in the “Hahn Air Match the Pairs Game” ends automatically.

VI. Limitations of liability

Hahn Air Lines GmbH is not liable for any damages unless such damages result from fraud, gross negligence or wilful misconduct of Hahn Air, or fraud, gross negligence or wilful misconduct of one of Hahn Air’s officers, agents, service partners or employees, or for damages to life, limb or health which were caused by negligence of Hahn Air or a negligent or wilful misconduct of one of Hahn Air’s officers, agents, service partners or employees. These liability provisions/regulations equally apply to the affiliates mentioned under section V.

Your participation in the “Hahn Air Match the Pairs Game” is free of charge. No product or service has to be purchased or received in connection to the “Hahn Air Match the Pairs Game”.

Unless otherwise defined, the terms and expressions used in these Terms and Conditions shall have the same meaning as used on www.hahnair.com.

The “Hahn Air Match the Pairs Game” and the Terms and Conditions of Participation are subject to the laws of the Federal Republic of Germany with the exclusion of the rules and regulations of Private International Law and the United Nations Convention on Contracts for the International Sale of Goods.

The place of fulfilment is Dreieich, Germany. Recourse to the courts is excluded as far as possible. As for the rest, Darmstadt, Germany is the exclusive place of jurisdiction for any claims or disputes arising out of or in connection with the “Hahn Air Match the Pairs Game” and/or these Terms and Conditions of Participation.
