

Terms and Conditions

Participation Hahn Air Lines' online game "Gate Runner"

Preface

Hahn Air Lines GmbH, hereafter to referred as Hahn Air, is organizing the "Gate Runner" online game and subsequent raffle. Owners and employees of travel agencies, hereafter to referred as "Participants" or "Travel Agents" can participate from 13th September 2023 12pm CET until 25th September 2023 6pm CET. Travel Agents can participate in the online game and can win a prize according to these Terms and Conditions of Participation.

I. Organiser

The "Gate Runner" online game and raffle is organized by Hahn Air Lines GmbH, An der Trift 65, D-63303 Dreieich, Germany. Hahn Air is the recipient of all information and messages that will be provided. Any questions, comments or complaints should be directed to Hahn Air through fun@hahnair.com.

II. Participation

The "Gate Runner" and participation in it are subject to the present Terms and Conditions of Participation. By participating in the "Gate Runner", the participant acknowledges and accepts the Terms and Conditions of Participation and that these are binding.

Participation in the "Gate Runner" is open to such employees of travel agencies who confirm that the owner of the agency has given the permission to participate and has accepted the Terms and Conditions. Only employees of these travel agencies who are of legal age may participate in the competition.

In order to participate in the online game you need to access www.hahnair.com and complete our "Gate Runner". The game's objective is to collect as many stars as possible and to avoid the obstacles in the game. Upon completion of the online game, you need to click on the save button to transfer your personal data, thereby automatically agreeing to our Terms and Conditions of Participation and participate in the drawing.

"Gate Runner" is only aimed at travel agencies from countries with legislations under which this online game and raffle is considered legal. You declare that your participation in the "Gate Runner" does not violate the laws of your country. If your travel agency is based in a country under whose legal system the "Gate Runner" online game and raffle is illegal, you may not participate in the drawing.

Travel agents who try to attempt to manipulate or interfere with the competition in any way, or who do not comply with the Terms and Conditions of Participation will immediately be excluded from participating in the "Gate Runner" raffle.

III. Winners, prizes, no entitlement to win, announcing the winner

The winners have to respond to the winner notification received via email by Hahn Air within 10 working days. Thereafter Hahn Air reserves the right to draw a new winner.

Hahn Air Lines reserves the right to modify or replace the prize at any time at its own discretion until the validity expires and without further notice. The data will be collected by Hahn Air Lines GmbH in connection with the “Gate Runner” and processed and used only for this purpose. The data collected in the context of the “Gate Runner” raffle will serve exclusively for identifying and notifying the participants and will not be exploited for any further purpose.

Data will not be transmitted to third parties, provided this is not necessary for the implementation and execution of the “Gate Runner”. You are aware of and consent that in order to implement the “Gate Runner” raffle, and in particular in order to announce the winner of the prize, a data exchange might be carried out between Hahn Air Lines GmbH, its sister companies and its mother company Saspo Holding GmbH. You hereby authorize Hahn Air Lines GmbH and its aforementioned affiliates to exchange such data and to use and process the data for the purposes of the “Gate Runner” raffle.

The data collected by the organizer within the framework of the “Gate Runner” will only be stored until the purpose for which they were collected has been fulfilled. Where retention periods stipulated by commercial and tax laws are to be observed, certain data may be stored for up to 10 years.

In the context of the “Gate Runner” the participants have declared to be in agreement with the collection, process und use of their personal data in the framework of the “Gate Runner”.

Unless otherwise defined, the terms and expressions used in these Terms and Conditions shall have the same meaning as used on www.hahnair.com.

The “Gate Runner” and the Terms and Conditions of Participation are subject to the laws of the Federal Republic of Germany with the exclusion of the rules and regulations of Private International Law and the United Nations Convention on Contracts for the International Sale of Goods.

The place of fulfilment is Dreieich, Germany. The Civil Court of , Darmstadt, Germany is the exclusive place of jurisdiction for any claims or disputes arising out of or in connection with the “Gate Runner” and/or these Terms and Conditions of Participation.
