

# Terms and Conditions of Participation

## *“Hahn Air 20th Anniversary Quiz – Mexico”*

### **Preface**

Hahn Air Lines GmbH is organising the “Hahn Air 20th Anniversary Quiz – Mexico” from February 7th, 2019 until February 19th, 2019, in which participating travel agencies (You!) can win prizes according to these Terms and Conditions of Participation.

### **I. Organiser**

The “Hahn Air 20th Anniversary Quiz – Mexico” is being organised by Hahn Air Lines GmbH, An der Trift 65, 63303 Dreieich, Germany (hereinafter: “Hahn Air”). Hahn Air is the recipient of all information and messages that will be provided. ### **II. Participation**

The “Hahn Air 20th Anniversary Quiz – Mexico” and your participation in it, are subject to the present Terms and Conditions of Participation. By participating in the “Hahn Air 20th Anniversary Quiz – Mexico”, you acknowledge and accept the Terms and Conditions of Participation and that these are binding.

Participation in the “Hahn Air 20th Anniversary Quiz – Mexico” is open to travel agencies, who have accepted the Terms and Conditions of Participation. Only employees of the travel agencies who are of legal age may participate in the drawing.

In order to participate in the drawing, you need to be logged in at [www.hahnair.com](http://www.hahnair.com) and complete our “Hahn Air 20th Anniversary Quiz – Mexico”. During the quiz, you will have to answer the quiz question by choosing one of the three answer options. Upon completion of the quiz, you need to click on the submit button to transfer your personal data, thereby automatically agreeing to our Terms and Conditions of Participation and participate in the drawing.

This “Hahn Air 20th Anniversary Quiz – Mexico” is only aimed at countries under which legislation this raffle is legal. You declare that your participation in the “Hahn Air 20th Anniversary Quiz – Mexico” does not violate the laws of your country. If your travel agency is based in a country under whose legal system the “Hahn Air 20th Anniversary Quiz – Mexico” is illegal, you may not participate in the drawing.

If any rule or regulation of the Terms and Conditions of Participation should be, or become invalid, the validity of the remaining terms and conditions shall remain unaffected.

Hahn Air reserves the right to end or to suspend the “Hahn Air 20th Anniversary Quiz – Mexico” at any time without prior notice. This applies in particular, but not limited to, any circumstances that disrupt or prevent the proper implementation or scheduled end of the “Hahn Air 20th Anniversary Quiz – Mexico”.

### IV. Winners, prizes, no entitlement to win, announcing the winners

There is no entitlement to win. Prizes cannot be transferred to third parties. Prizes will not be paid out in cash.

The winners of the “Hahn Air 20th Anniversary Quiz – Mexico” will be determined by a drawing of all correctly submitted entries of all the participants on February 19th, 2019 at 12:00 (CET) at the main office of Hahn Air Lines GmbH , An der Trift 65, 63303 Dreieich, Germany.

The first prize is a ‘Trip for 2 to our Birthday Party in Mexico City, taking place in Mexico City on March 14<sup>th</sup>, 2019.

If you win, you will be asked to give your consent to publish your name, travel agency and city in Hahn Air’s newsletter, on Hahn Air’s website and social media pages ([www.hahnair.com](http://www.hahnair.com), Facebook, Twitter, etc). If you win the first prize ‘Trip for 2 to Birthday Party in Mexico City’, you and your travel mate will be asked to give your consent that also photos and videos taken at the event with you can be published on the internet and social media pages ([www.hahnair.com](http://www.hahnair.com), Facebook, Twitter, etc.) as well as Hahn Air Newsletters.   - If the travel agent cannot travel or take part, the trip will be cancelled and cannot be postponed.

Data will not be transmitted to third parties, provided this is not necessary for the implementation and execution of the "Hahn Air 20th Anniversary Quiz – Mexico".
